RESPONSE TO REQUESTS FOR EXTENSION OF THE SUBMITTAL DATE FOR STAKEHOLDER DEVELOPED SALT AND NUTRIENT MANAGEMENT PLANS

In March and April 2014 the Los Angeles Regional Water Quality Control Board (Los Angeles Water Board) received your requests for extensions of the May 2014 deadline for submittal of your Salt and Nutrient Management Plans, as required by the State Water Board's Recycled Water Policy (Policy). This Policy requires Salt and Nutrient Management Plans (SNMPs) to be developed for all groundwater basins/sub-basins in the state, through a stakeholder led process - with participation by Los Angeles Water Board staff. The Policy also allows for an extension of the submittal deadline by up to two years where the Los Angeles Water Board finds that stakeholders are making substantial progress towards completion of a plan.

The Los Angeles Water Board is aware of, and commends, the efforts of your stakeholder groups to develop SNMPs for each groundwater basin in a manner that will allow for their long-term, sustainable beneficial use. Los Angeles Water Board staff has been participating in this development process and is therefore aware of the need for additional time to complete the tasks required for comprehensive SNMPs for the groundwater basins.

The Executive Officer hereby approves the additional time requested by each of the basin stakeholders as provided in the table below.
